



## 5,522 people have died within 28 days of having a Covid-19 Vaccine in Scotland according to Public Health Scotland

Due to dozens of freedom of information requests being made, asking Public Health Scotland (PHS) to provide the current total number of deaths of any individual who has died within 28 days of having a Covid-19 vaccine, PHS decided the best way forward was to publish the information routinely and periodically within their Covid-19 statistical report.

Dear Mark McKee,

Thank you for your email of 24 May.

I can confirm that the information will be published between now and 22nd June 2021. This will be published in our COVID-19 Statistical Report which can be accessed via

I can also advise that PHS is currently dealing with 21 current live cases to which we have applied the same exemption as in your case. It is because of the number of such cases that we have decided to make a routine, periodic, publication of this information to the public following the forthcoming initial release, rather than to individual FOI requests. We hope this will be of greater use to the public in future.

The most up to date figures published by PHS and within the report released by on the 23<sup>rd</sup> June 2021, and they reveal that between the 8<sup>th</sup> December 2020 and the 11<sup>th</sup> June 2021 a total number of 5,522 people died within 28 days of having a dose of a Covid-19 vaccine.

According to the spreadsheet provided by Public Health Scotland; which includes the quantity of deaths by type of vaccine and the date they occurred, 1,877 deaths have been due to the Pfizer mRNA jab, 3,643 deaths have been due to the AstraZeneca viral vector jab, and 2 deaths have been due to the Moderna mRNA jab.

## **Public Health Scotland**

Between 8 December 2020 and 11 June 2021, a total of 5,522 people died within 28 days of receiving a COVID-19 vaccine in Scotland (number of days between vaccine and death is 0-27, where 0 is the day of vaccination, all age groups). A breakdown of these deaths by day and vaccine type is available in the <a href="mailto:spreadsheet">spreadsheet</a> provided along with this report.

This equates to an average of 920 deaths occurring every month due to the Covid-19 vaccines in Scotland alone. Outnumbering the average number of people who have died of Covid-19 in Scotland by 866 per month.

A freedom of information request made on the 30<sup>th</sup> January asked the Scottish Government to reveal the total number of people who had died of Covid-19 since March 2020.

To which the Scottish Government responded on the 11th March 2021 with –

"The answer to your question is 596 deaths involving COVID-19 has been registered where there was no pre-existing medical condition between March 2020 and January 2021 (including)."

Public Health England has so far refused to publish any data on the number of deaths occurring within 28 days of having the vaccine in England, but it is not for the want of people trying.

## Information requested

The figure of deaths in Scotland for the period of 3/3/2020 till 1/2/2021 of citizens whom have died solely of COVID-19 with no whatsoever underlying conditions.

## Response

The answer to your question is 596 deaths involving COVID-19 has been registered where there was no pre-existing medical condition between March 2020 and January 2021 (including).

Dozens of freedom of information requests have been made to PHE asking the question but they never fail to respond with the statement that "Public Health England can confirm it does not hold the information that you have requested.

I would like to request to see the exact mortality figures for people who have died within 28 days of receiving the vaccination against coronavirus, for any reason, in England only.

Please can this include the dates from the start of the vaccination roll out to today's date, 29th April 2021.

Dear Fiona Marshall,

Public Health England can confirm that it does not hold the information you have requested.

However, using the data on the number of deaths due to the Covid-19 vaccines in Scotland we can estimate what the likely number of deaths are due to the jabs in England. Adjusting to the size of the population we estimate the actual

number of deaths due to the jabs in England in the past 6 months could be as high as 57,470.

That number alone is precisely why PHE "claim" they do not hold that information.
