EXECUTIVE ORDER NO. 2021 – 040

AN ORDER TEMPORARILY SUSPENDING CERTAIN ACTIVITIES AND IMPOSING STRICTER RESTRICTIONS IN THE CITY OF LAPU-LAPU DURING THE PERIOD OF MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) FROM 12 MIDNIGHT OF JULY 26, 2021 TO 12 MIDNIGHT OF 25 AUGUST 2021

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases has placed the City of Lapu-Lapu under Modified General Community Quarantine until 31 July 2021;

WHEREAS, the City of Lapu-Lapu is currently experiencing a surge of COVID-19 positive cases; At present, there are 763 active cases in the city and a positivity rate of 19.7 percent, which now brings the total confirmed cases to 8031;

WHEREAS, the Department of Health has confirmed the presence as well as community transmission of the highly infectious and transmissible Delta variant. There are already 119 confirmed cases of Delta variant in the Philippines;

WHEREAS, while it is fortunate that there are no confirmed cases of Delta variant in the City of Lapu-Lapu, the city must still take utmost precautions to prevent the spread of the COVID-19 Delta variant and stop further increase of positive cases;

WHEREAS, upon the assessment of the Emergency Operations Center (EOC) and city's COVID Prevention Task Force, there is a need to temporarily suspend certain activities that are considered "super spreaders" which are allowed during the period of Modified General Community Quarantine (MGCQ) in order to prevent the spread and exposure of the virus and protect the general welfare of all Opongonans;

NOW THEREFORE, I, JUNARD "AHONG" Q. CHAN, Mayor of the City of Lapu-Lapu, and by the virtue of the powers vested in me by law, do hereby order the **TEMPORARY SUSPENSION OF CERTAIN ACTIVITIES AND IMPLEMENTATION OF MEASURES TO FIGHT THE SPREAD OF COVID19** in the City of Lapu-Lapu effective 12 midnight of 26 July 2021 to 12 midnight of 25 August 2021, to wit:

SECTION 1. TEMPORARY SUSPENSION OF ACTIVITIES DURING THE PERIOD OF MODIFIED GENERAL COMMUNITY QUARANTINE – The following activities are temporarily suspended from 12 midnight of 26 July 2021 to 12 midnight of 25 August 2021, unless sooner lifted, namely:

1. All forms of non-contact and contact sports and sporting events;
2. All types of non-essential mass gatherings (i.e. zumba and group exercises, fiestas, general assemblies, work-related conferences, trainings, MICE events, and other similar activities that entail gathering of persons).

The movement of all persons shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate and for other activities permitted under the IATF Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines under Modified General Community Quarantine (MGCQ).

Provided that weddings, birthday parties, and baptisms, are not included in the list of activities to be suspended provided that there shall be strict compliance of existing public health safety standards (i.e. wearing of face mask and face shield, social distancing, curfew, and 50% venue capacity limitation), and no liquor shall be served in any of these activities whether in held in a public or private place (i.e including residences)

Provided further, that wakes and funerals shall only be allowed for a maximum of three (3) days and there shall be compliance of the curfew period.

Any special permit issued to any person, establishment, organization, or company that has been previously issued prior to the issuance of this Executive Order is hereby revoked immediately.

SECTION 2. LIQUOR BAN – The drinking or consumption of all types of liquor shall be prohibited in Lapu-Lapu City effective 12 midnight of 26 July 2021 to 12 midnight of 25 August 2021 in public and private places including restaurants and bars.

However, hotels, resorts, and other accommodation establishments are allowed to serve liquor to in-house guests within their respective rooms only.

Moreover, serving and consumption of liquor in a mass gathering within a private residence shall likewise be prohibited.

SECTION 3. BAN ON VIDEOKE AND KARAOKE ACTIVITIES– Effective 12 midnight of 26 July 2021 to 12 midnight of 25 August 2021, all karaoke activities, whether in private residences or duly licensed karaoke bars shall be prohibited. Executive Order No. 2020-95 which regulates karaoke activities is hereby repealed.

Business establishments, which offer both food services and karaoke activities, shall be authorized to operate but only for its food services.

SECTION 4. PRESENTATION OF VACCINATION CARDS IN PUBLIC AND PRIVATE MARKETS, SUPERMARKETS, CONVENIENCE STORES, DEPARTMENT STORES – Effective 25 August 2021, only vaccinated persons, upon presentation of their vaccination cards, shall be allowed to enter public and private markets including department stores, supermarkets, grocery stores, and convenience stores.

SECTION 5. SHUTTLE SERVICE FOR EMPLOYEES RESIDING OUTSIDE LAPU-LAPU CITY – All business establishments most especially locators at the Mactan Economic Processing Zones, are urged to provide shuttle services for its employees who reside outside Lapu-Lapu City.

SECTION 6. REITERATION OF GUIDELINES FOR DINING IN FOOD ESTABLISHMENTS – Dine in services shall comply with the following guidelines:

1. All restaurants and fastfood businesses operating in Lapu-Lapu City, regardless of the size of the establishment, including canteens, food courts, food parks, and other eateries providing dine-in services may operate at a maximum of fifty percent (50%) of its operational capacity for dine-in services
2. Restaurants and fastfood businesses shall be prohibited from serving alcoholic drinks;
3. Any establishment authorized to operate for 24 hours shall only be allowed to offer take-out services after 10:00 PM.
4. All dine in services and transactions shall be delivered as fast and as contactless as possible;

SECTION 7. STRICT IMPLEMENTATION OF PUBLIC HEALTH SAFETY STANDARDS

1. The Lapu-Lapu City Police Office and duly accredited force multipliers are hereby directed to strengthen monitoring in all the borders of the city and to ensure ample manpower in all checkpoints;
2. The Lapu-Lapu City Police Office and all the 30 barangays of the city are hereby directed to apprehend, arrest, or impose penalties on any person who commits any of the following:
 - a. Non-wearing of face mask and face shield;
 - b. Improper wearing of face mask and face shield;
 - c. Non-compliance with the 50% venue capacity limitation;
 - d. Non-compliance with the social distancing requirement;
 - e. Non-observance of the curfew period from 10:00 PM to 05:00 AM the next day;
3. The City Traffic Management System (CTMS) is directed to issue traffic citations and impose penalties on any person who commits any of the following:
 - a. Non-compliance of social distancing;
 - b. Non-compliance of the No Mask, No Face Shield, No Ride policy;
 - c. Overloading of passengers (i.e. more than 2 passengers for tricycles, more than 9 passengers for multicabs, more than 15 passengers for modern jeepneys);

- d. Non-wearing of face masks by drivers;
4. The Lapu-Lapu City Business Permit and Licensing Office is hereby directed to inspect all business establishments to check compliance on the following:
- a. Curfew period;
 - b. No mask, no face shield, no entry policy;
 - c. Contact tracing forms and presence of contact tracing applications;
 - d. Liquor ban;
 - e. Karaoke and videoke ban;
 - f. Social distancing within business premises;
 - g. 50% venue capacity limitation;
 - h. No entry of any person below 15 years old and above 65 years old;
 - i. Other regulations imposed under existing laws, rules, regulations, ordinances, and orders;


SECTION 8. VIOLATIONS. Violation of any provision of this Order and other earlier Executive Orders issued in relation to the Covid-19 pandemic, shall be subject to penalty pursuant to existing national law and local ordinances.

SECTION 9. SEPARABILITY CLAUSE. If any part or provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected shall remain valid and subsisting.

SECTION 10. REPEALING CLAUSE. All issuances inconsistent herewith are hereby superseded accordingly.

SECTION 11. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain in force unless otherwise superseded or modified by subsequent Executive Orders and other issuances.
